The Company and its History



The Commonwealth of Dominica is also known as the "Nature Island of the Caribbean" because of its wide variety of flora and fauna and extensive natural park system.


The island boasts hundreds of acres of rainforests, several waterfalls, rivers, lakes, and untouched nature reserves.

Investment Option

Dominica's citizenship program requires its applicants a certain amount of economic contribution to the country. In exchange, applicants and their families are granted full citizenship. The economic contribution would be in the form of a direct non-refundable payment made to the Government.

There are four options for obtaining citizenship:

» Single Applicant:

A non-refundable investment of 100,000 USD.

» Main Applicant and Spouse:

A non-refundable investment of 175,000 USD.

» Main Applicant with up to 3 qualifying dependents:

A non-refundable investment of 200,000 USD.

For an additional qualifying Dependent:
Other than a spouse, a non-refundable contribution of 25,000 USD per dependent.


